Hi, Bonnie, I'm Detective Roberts of the Fort Hall Police Department. How are you doing? (wind noise)...the Council and they're drafting a resolution regarding this (noise)....It's not signed.

"Whereas, Darrel Auck, a member of the Shoshone Bannock Tribes, was murdered on or about October 15, 2014, on the Fort Hall Reservation by Anthony Ish, also a member of the Shoshone Bannock Tribes, and

"Whereas, as Darrel's body has not been found and Tribal members Bonnie Ish, Frank Ish, Aarika Ish, Demetres Ish, and Jonathan Ish, Sr., Cecyle Perez and Jennine Sittre have knowledge, or should have knowledge, regarding the location of Darrel's body and either fail or refuse to cooperate with law enforcement in locating Darrel's body,

"Now, therefore, be it resolved by the Business Council of the Shoshone Bannock Tribes, the above individuals are hereby disenrolled from the Shoshone Bannock Tribes effective immediately and further banished from the Fort Hall Reservation forever. In addition, no children born or adopted by the above former Tribal members shall be eligible for enrollment in the Shoshone Bannock Tribes.

"Be it further resolved that any and all Tribal benefits, including, but not limited to, hunting, fishing, gathering, gaming, per caps, are hereby withdrawn effective immediately and forever denied to the above individuals and their issue."

This hasn't been signed by the Council, but they are probably going to. All they want is the body of Darrel Auck so they can return it to the family. That's the mission of this, is to return that body. Because it's no longer a law enforcement matter, apparently, who are called down there. Basically, it's a society as a whole issue, so they asked us to come out and read this to you. They want you to know how serious it is and they just want the body returned. If you guys want to call Bill Bacon's office, you know, the Tribal attorney's office, and just tell them and they'll tell us. Whatever, but that's the main purpose behind the letter, okay? And that's all I have. Do you have any questions of me? (no) Okay, thank you Bonnie.
