The Grand Jury charges:

COUNT I

On or about between August 1, 2016, and November 11, 2016, near Kyle, in Indian country, in the District of South Dakota, the defendants, Roberta Featherman, Darshan Featherman, and Harold Red Owl, Indian persons, aiding and abetting each other, did unlawfully assault [Name Redacted], a person who had not attained the age of 18, said assault resulting in serious bodily injury, all in violation of 18 U.S.C. §§ 1153, 2, 113(a)(6), and 3559(f).

COUNT II

On or about between August 1, 2016, and November 11, 2016, near Kyle, in Indian country, in the District of South Dakota, the defendants, Roberta Featherman, Darshan Featherman, and Harold Red Owl, Indian persons, aiding

and abetting each other, did unlawfully assault [Name Redacted], a person who had not attained the age of 18, said assault resulting in serious bodily injury, all in violation of 18 U.S.C. §§ 1153, 2, 113(a)(6), and 3559(f).

COUNT III

On or about between August 1, 2016, and November 11, 2016, near Kyle, in Indian country, in the District of South Dakota, the defendants, Roberta Featherman, Darshan Featherman, Harold Red Owl, Terry Featherman, Tressa Means Featherman, Jeff Shoulders and Rainbow Spoonhunter, Indian persons, aiding and abetting each other, did intentionally and knowingly abuse, expose, torture, torment, and cruelly punish [Name Redacted], a child who had not attained the age of seven years, all in violation of 18 U.S.C. §§ 1153 and 2 and SDCL § 26-10-1.

COUNT IV

On or about between August 1, 2016, and November 11, 2016, near Kyle, in Indian country, in the District of South Dakota, the defendants, Roberta Featherman, Darshan Featherman, Harold Red Owl, Terry Featherman, Tressa Means Featherman, Jeff Shoulders and Rainbow Spoonhunter, Indian persons, aiding and abetting each other, did intentionally and knowingly abuse, expose, torture, torment, and cruelly punish [Name Redacted], a child who had not attained the age of seven years, all in violation of 18 U.S.C. §§ 1153 and 2 and SDCL § 26-10-1.
