⁹ The Balanced Budget and Emergency Deficit Control Act of 1985 had authorized an adjustment to the discretionary spending caps for appropriations designated by the Congress as being for "disaster relief" provided those appropriations are for activities carried out pursuant to a determination under the Robert T. Stafford Disaster Relief and Emergency Assistance Act. The 2022 Budget maintains the same methodology for determining the funding ceiling for disaster funding for 2022 and OMB currently sets its request at the estimated ceiling of \$18.9 billion. Further details, including any revisions necessary to account for changes to the ceiling estimate and the specific allocations of disaster relief funding requested for 2022, will be provided in the Budget.
