The Native American Graves Protection and Repatriation Act (NAGPRA or the Act) recognizes the rights of lineal descendants, Indian Tribes, and Native Hawaiian organizations in Native American human remains, funerary objects, sacred objects, and objects of cultural patrimony. Native American human remains and cultural items subject to NAGPRA are held by museums and Federal agencies or may be discovered on Federal or Tribal lands. Administrative responsibilities under the Act are assigned to the Secretary of the Interior, who delegated certain tasks to the National NAGPRA Program (Program).

This report covers Program activities related to the following delegated tasks during Fiscal Year 2023 (October 1, 2022- September 30, 2023) in the Act at 25 U.S.C. § 3001 et seq.:

§ 3002: Protection on Federal or Tribal Lands

- Providing technical assistance concerning the excavation and discovery of cultural items
- Maintaining a database of Notices of Intended Disposition published by Federal agencies
- Maintaining a list of unclaimed cultural items held by Federal agencies

§ 3003, 3004, & 3005: Repatriation by Museums and Federal Agencies

- Receiving inventories and summaries prepared by museums and Federal agencies
- Publishing notices in the Federal Register for museums and Federal agencies
- Maintaining information about inventories, summaries, notices, and Federal agency repatriations

§ 3006: Review Committee

Providing staff support and a Designated Federal Officer to the Federal advisory committee

§ 3007: Civil Penalties

• Providing staff support on allegations of museums who fail to comply with the Act

§ 3008: Grants

Administering a grant program to assist museums, Indian Tribes, and Native Hawaiian organizations

§ 3011: Regulations

Drafting and updating regulations

§ 3012: Appropriations

• Carrying out the Act using the funds appropriated

Providing assistance to any party on any of the responsibilities under the Act

NAGPRA notices more than doubled – the number of notices published in the Federal Register was more than double the previous year and the largest number ever published in one year.

NAGPRA activity increased – the number of human remains that have completed the regulatory process grew by 6%.

NAGPRA funding increased –available grant funds increased to \$3.407 million, the largest amount ever available.

More NAGPRA work needed – Over 96,000 Native American individuals are still in collections and 90,803 of those have not been culturally affiliated with any present-day Indian tribe or NHO. Cultural affiliation and consultation could resolve the rights to these individuals, especially in states like Illinois (15,136), Ohio (10,894), California (7,385), and Florida (6,083)...

NAGPRA Accomplishments FY 1990 – FY 2023

For the first time since 1990, more than 50% (116,978) of the Native American human remains reported have completed the NAGPRA process.

Over 2 million associated funerary objects have completed the NAGPRA process with human remains.

38% of museums subject to NAGPRA have resolved all Native American human remains under their control.


More than 358,000 unassociated funerary objects have been published in notices.


About 31,264 other cultural items have been published in notices.

85 Review Committee meetings have been held between FY 1990-FY 2023.

\$59,111 has been collected in civil penalties for failures to comply.

\$59 million has been awarded in NAGPRA grants.

§ 3002: Protection on Federal or Tribal Lands

Notices of Intended Disposition

The Program received copies of 16 Notices of Intended Disposition published in newspapers by Federal agencies. Since 1990, 238 notices have been published. See https://grantsdev.cr.nps.gov/NagpraPublic/Home/NID.

Unclaimed Cultural Items

§ 3003, 3004, & 3005: Repatriation by Museums and Federal Agencies

Inventories of Native American human remains and associated funerary objects

The Program received 15 new inventories. A total of 402 museums and 120 Federal agency units report 96,488 Native American human remains in inventories of their holdings or collections. See https://grantsdev.cr.nps.gov/NagpraPublic/Home/Inventory.

Summaries of Native American cultural items

The Program received 14 new summaries. Since 1990, 1,566 museums and Federal agency units have submitted summaries to the Program. See https://grantsdev.cr.nps.gov/NagpraPublic/Home/Summary.

Federal Register Notices

The Program received 475 notice submissions this year and published a total of 446 notices. Since 1992, 4,447 notices have been published. See https://grantsdev.cr.nps.gov/NagpraPublic/Home/Notice.

Repatriation

The Program does not have comprehensive data on the transfer (i.e. repatriation or disposition) of human remains or cultural items following the publication of a notice in the *Federal Register*. Since 2011, the Secretary of the Interior has required that Federal agencies submit data annually on completed repatriations. Each year, the Program sends a data request to each Federal agency for a report on the Federal agency's cumulative repatriation data.

§3006: Review Committee

Members and Meetings

The Review Committee held 3 public meetings this fiscal year. Since 1992, the Review Committee has held 85 public meetings. See https://www.nps.gov/subjects/nagpra/review-committee.htm.

The Review Committee made 4 recommendations to the Secretary of the Interior on disposition requests this fiscal year. Since 1992, the Review Committee has heard and acted on 118 requests for human remains with no cultural affiliation. Of these requests, 115 were requests for disposition of particular sets of human remains, and 3 were requests to consider and approve a state process for disposition. §3007: Civil Penalties

Allegations and Findings

The Program received 13 letters alleging that a museum failed to comply with the Act. Since 1996, the Program has received 135 unique allegations of failure to comply. Of that total, 37 allegations were not substantiated, and the Department determined there was no failure to comply. For one allegation, the Department declined to investigate the allegation. The status of other allegations are described in the two tables below.

Technical Assistance

The Program corresponded with over 800 people at nagpra_info@nps.gov and over 200 phone calls to 202-354-2201. In addition, each staff member responded to direct inquiries. This does not include correspondence on notices, which accounts for another 700 emails this year. Much of the email and phone calls results in referrals to information on the Program website https://www.nps.gov/nagpra. Analytics for the website show 191,656 pageviews and 7,019 unique download events. The top pages visited were the home page, compliance page, getting started page, regulations page, and databases. Since 2012, the Program has hosted https://www.youtube.com/@NationalNAGPRA. This fiscal year, the channel received over 8,959 views and 635 subscribers.
