Greetings Ohkay Owingeh,

- **COVID Update** – The case count for Ohkay Owingeh as of today is as follows:
Total Cases: 80
Recovered: 57
Active Cases: 23
- **Vaccinations for COVID 19** – The first of the Pfizer vaccine is being administered today. Ohkay Owingeh was able to get 8 health care workers vaccinated. The Moderna vaccine could get approval today. As I indicated last week there is a priority identification of who gets the vaccine's first. Below is more detail as to the prioritization and tentative dates on when this will all happen.

Phase 1(a) (Happening Now) – health Care workers providing care to Covid 19 patients

Phase 1(b) (January/February) – Essential workers includes teachers, food and agriculture, Utilities, Police, fire etc.

Phase 1(c) Winter 2021 – Adults w/ high risk medical conditions and seniors

Phase 2 (Early Spring/Summer 2021) – Vaccine available for some general public. Focus on areas of high positivity rate.

Phase 3 (Summer/Fall 2021) – Vaccine available to general public

Dear Tribal Leader and Urban Indian Organization Leader(s),

The Indian Health Service Albuquerque Area Incident Command System (IHS-AA-ICS) Team is coordinating efforts for COVID-19 Vaccination distribution in alignment with the COVID19 Vaccination Program Interim Playbook Version 2.0 and the IHS Vaccine Task Force guidance documents.

In Phase 1a of the COVID-19 vaccine distribution, allocations will include vaccines from two different pharmaceutical manufacturers, Pfizer-BioNTech® and Moderna®. The first vaccine to be distributed will be the Pfizer-BioNTech® ultracold vaccine. On 12/12/20, the U.S. Food and Drug Administration has issued an Emergency Use Authorization (EUA) for the Pfizer-BioNTech® vaccine for the prevention of COVID-19 for individuals 16 years of age and older caused by SARS-CoV-2. This EUA represents the first vaccine authorized for the prevention of COVID-19. The first distribution of the vaccine will be shipped by the pharmaceutical manufacturer to a central location in Albuquerque, NM. After the Albuquerque Area receives the vaccine, it will be redistributed to health facilities within the Albuquerque Area IHS.

Within the next 2 weeks, the second vaccine, manufactured by Moderna®, will be reviewed by the FDA advisory panel, with anticipated FDA EUA status 10-14 days after Pfizer's vaccine approval. The first distribution of the Moderna® frozen vaccine will be shipped directly to healthcare facilities by McKesson.

The COVID-19 vaccine is anticipated to be allocated in three phases based on vaccine approval and availability, moving from targeted to broader populations. The three phases are a recommendation by the Advisory Committee on Immunization Practices (ACIP), which is a committee within the Centers for Disease Control and Prevention (CDC).

On November 16, 2020, the IHS-AA-ICS submitted to the IHS Vaccine Task Force all healthcare facilities' priority group projected numbers that were received by participating Federal/Tribal/Urban sites. The IHS vaccine distribution and allocation plan aligns with CDC and ACIP recommendations for priority populations, which will be as follows:

Phase 1: Limited supply of COVID-19 vaccine doses available

- **Phase 1a: Mid - Late December 2020**
 - Health Care Personnel
 - Long Term Care Facilities residents
 - Skilled Nursing facilities, Nursing Homes, and Assisted living facilities
- **Phase 1b: Winter 2021 January/February**
 - Essential Workers (examples: Education Sector, Food & Agriculture, Utilities, Police, Firefighters, Corrections Officers, Transportation)
- **Phase 1c: Winter 2021**
 - Adults with high-risk medical conditions
 - Adults +65y

Phase 2: Large number of vaccine doses available; Early Spring - Summer 2021

- Focus on ensuring access to vaccine for all critical populations who were not vaccinated in Phase 1, as well as for the general population; expanded provider network.

Phase 3: Sufficient supply of vaccine doses for entire population; Summer – Fall 2021

- Focus on ensuring equitable vaccination access across the entire population. Monitor vaccine uptake and coverage; reassess strategy to increase uptake in populations or communities with low coverage.

On 12/10/20, the IHS Vaccine Task Force team in conjunction with the CDC finalized the allocation distribution of the initial Phase 1a priority group vaccine distribution which we anticipate to be:

- 40% in the initial delivery from Pfizer-BioNTech® and
- 40% (average) in the initial delivery from Moderna®.

It is estimated health care sites will be able to vaccinate approximately 80% of the Phase 1a priority group with the combined doses received from Pfizer-BioNTech® and Moderna®. The Albuquerque Area IHS expects to receive more vaccines from additional pharmaceutical companies manufacturing COVID-19 vaccines following the initial Phase 1a distribution. As more vaccines become available in the coming weeks to months, opportunities to vaccinate into Phase 1, Phase 2, and Phase 3 groups will be a priority. Furthermore, we are continuing to optimize our vaccine distribution and handling process to deliver the vaccine in a timely and safe manner.

- **COVID Update** – The case count for Ohkay Owingeh as of today is as follows:
Total Cases: 67
Recovered: 35
Active Cases: 24

On Saturday Dec 5, 2020 we tested 167 people, there have been no positives as a result of this testing. Please keep it up your doing good.

- **Vaccinations for COVID 19** – The plan for vaccinations will be based on priority ranking. The priority group targeted to receive the first vaccinations will be health care workers or anyone who is treating and or caring for COVID infected patients. We have identified and submitted our list. They will start receiving the first of a two series vaccination next week at IHS in Santa Fe. As time goes on and more vaccine becomes available the priority list will be expanded to include front line workers, those with pre-existing conditions, etc. and then eventually to the general public. It is not likely that this vaccine becomes available to the general public until maybe May – June of 2021.

Is the vaccine safe? We are trying to get as much information as we can about the vaccines and we will share as soon as we can right now there are two the first is made by pharmaceutical company called Pfizer, the second is by a pharmaceutical company called Moderna, both require a two shot series. We are doing our best to research and inform you but you too should look into these yourself and make your own decision.

- **COVID General Assistance Program** – I wanted to make you all aware that the COVID General Assistance money that we have been able to provide to many of you during this pandemic is coming to an end. The Tribal Council was pleased to be able to help all of you during this challenging time. We will have disbursed over \$4 million dollars in assistance through this program. This does not affect the current disbursement which the deadline is today for submission of application.
- **Vaccinations for COVID 19** – As you may heard from the news media we are expecting the CDC to approve the first vaccines for COVID -19 on Tuesday Dec 10, 2020. We have been working with IHS and New Mexico Department of Health to ensure Ohkay Owingeh has access to the vaccinations and a plan for getting them to you. COVID Cases – Our community positives are now at 50 since the pandemic began. We have 22 positives that have recovered, so as of today we have 27 active cases. There is no doubt the virus is here; Yesterday's Rio Arriba County count was at 85 positives just for one day. Please stay home avoid un-necessary travel. COVID Testing – In response to the increase in cases we have arranged for another testing session. It will be on December 5, 2020 at the north parking lot of the Ohkay Casino from 9:00am – 12:00 pm. If you want to be tested please plan on attending.

General Assistance 3rd Round – The Tribal Council has authorized a third round of General Assistance. It is the tentative plan to make applications available the week of November 23, 2020 with a final due date of December 4, 2020. Checks will start being mailed out the week of December 11, 2020.

COVID Cases – Our community has had 25 positives, there are currently 8 active cases. This means that 16 have recovered and unfortunately, we have had 1 fatality. Please stay home avoid un-necessary travel. In almost every instance the positives in our community are a result of Travel, especially among your people. Like many things in life it's all about our decisions, please be wise and adhere to the recommendations.

Thanksgiving Holiday - As many of you probably noticed we deployed law enforcement and closed off many roads during Halloween to help stop movement and interaction. The effort was successful, and we plan to do the same thing during the Thanksgiving holiday. Please do not plan large family gatherings keep it to those who live in your household.

Beware of Scams – Ohkay Owingeh Public Safety Divisions has alerted us that scammer's have been contacting community member's posing as FBI, DEA and IRS. Scammer's are threatening with arrest if a monetary payment is not sent to a discreet account. The call-in number appears to be that of our Police Department. If you receive any calls, please hang up and contact Police Department at (505) 852-2757.

Tribal Admin Office Closure – We have once again closed our administrative offices. We are still here to provide services however the building doors will be locked. Please call and make an appointment with the department you need to see. Posted on the door, or on this web page are all the phone numbers. Many of the staff are working from home as well so please be patient.

Water Bills – The Ohkay Owingeh Tribal Council has issued a reprieve on water bill payments for 2020. This means YOU DO NOT NEED TO PAY, your water will not be shut off. This action applies from the month of March 2020 thru December 2020. It does not have any impact on any outstanding balances prior to March 2020.

Greetings Ohkay Owingeh,

- It has been 7 months now since this pandemic started, and it does appear that things have improved on all fronts. Thank you for your efforts in keeping our community safe. However, your COVID response team has raised a new and upcoming potential problem. Flu/cold season is upon us and given the still on-going COVID-19 pandemic there could be a lot of confusion and or misinterpretation of symptoms. It is for this reason that we are *strongly recommending that all of you consider getting the flu shot this year.* We are in the process of developing some programs whereby we will have some free flu shot clinics for you, please watch for these and consider getting the influenza vaccine.
- There is approximately 2 weeks, 3 days left to complete the 2020 census. Our numbers are at 34% meaning based on the residents we know we still lack about 65% of our population. Most recently we helped the Census hire about 10 more Ohkay members to visit homes. Please let them help you and or do it yourself but I'm asking you to make an effort to complete the 2020 CENSUS.
- Utility Bills – We have suspended the collection of utility payments. I mentioned this early on but we seem to have a lot of folks coming in trying to make payments. We appreciate your consideration, but you need not worry we are not collecting or turning off water during this pandemic. I also want to communicate that we have no intention of collecting for these months.

- Lastly, we have personal protection equipment (PPE) = masks and it is available for you and your families. If you need PPE please call 505.852-2458, Ohkay CHR program.

Greetings Ohkay Owingeh,

- I. COVID-19 - As the state of NM puts back in place certain restrictions we felt compelled to communicate some strategies or opportunities to enhance our safety by providing additional guidelines so as to further minimize the chance of harm to our Pueblo members.
 1. Travel – Please limit your travel outside of Ohkay Owingeh to only essential needs.
 2. Work – If you are working do your best to protect yourself, especially if your job brings you in contact with a lot of people.
 3. Social Distance – If you do go out or are working keep your distance from others.
 4. Wear face Covering – If you go out to the store, out to work, or anywhere there is people cover your mouth and nose with a covering.
 5. Wash Your Hands – If you go out as soon as you get back in your vehicle or to your house immediately wash your hands or use hand sanitizer. Consider a gas station and the gas pumps, you have no idea how many people have touched the pumps. And you have no idea from where these folks came. Just in a given day 1 pump sees on average about 100 people or has 100 touches.
 6. Outside Visitors – Discourage family and friends from visiting Ohkay Owingeh.

We want to remind you of Ohkay Owingeh's ability to work with you and assist you in getting tested. If for **any reason you want to be tested please contact us and we will help get you tested.** We must all pray that any spread is below the curve to allow our hospitals and clinics the means to take care of any loved ones.

You as a tribal member of Ohkay Owingeh can do your part to slow/alter/limit/ any spread of COVID-19 by following the recommendations listed above.

Its been a while since my last communication, the reason I have not communicated is because things are still very much the same as the last update on June 11, 2020. I do want to tell you that we have had a couple of really “scary moments”, which thankfully turned out to be non-issues. However, upon reflection of these “scary moments” It occurred to me that there is 1 common denominator to each of these moments, let me explain.

The “scary moment” starts with a verified positive individual that was recently here at Ohkay Owingeh or an Ohkay Owingeh was at a location outside of here where they had contact. This immediately causes all who had contact with the individual to be quarantined and to have to get tested. This is simple enough to state but it takes an enormous amount of time and coordination and I would imagine anxiety to those who came in contact with the verified positive individual. To date we have been fortunate and there has been no infection here, but the common denominator is that in every one of these “scary moments”, the possible exposure happens because of contact with folks who reside outside our lands. What I’m saying to you, **IS IF YOU STAY HOME YOU REDUCE THE POSIBILITY OF EXPOSURE.**

- Stay at Home Order – Ohkay Owingeh is still recommending that you limit travel and to the degree possible stay home. Now this being said I realize the State of NM has started a phased re-opening of businesses and services. So, all we are asking is that you continue to be careful and really consider if you need to go out or not. You all have a done great job and I commend everyone but let's not let up to soon, so please keep it up.
- Monetary Assistance Available – Ohkay Owingeh has identified resources to offer financial assistance to any Tribal Member who has experienced financial hardship due to the COVID-19 Pandemic. On the web page is a form that you MUST complete in order to receive the funds. Please read carefully the instructions and fill the form completely. All checks will be mailed therefore an accurate address is a must.
- Ohkay Casino Phased Re-opening – Yesterday Ohkay Owingeh Tribal Council approved a phased or partial re-opening of the Ohkay Casino on June 15, 2020. There has been a lot of planning, and preparation by the Casino Mgt, Gaming Commission and Ohkay Owingeh Health & Human Services Division. Id like to address some potential questions in this regard;
 - What's Open? The Hotel opened on June 1 in line with State of NM lifting restrictions on Hotels and Restaurants. The Snack bar is open for carry out only. On June 15, 2020 part of the gaming floor 40% will open.
 - What will remain closed? Lounge, Conference Center, and Buffet.
 - Will Mask be required? Masks will be required for all staff, and it will be strongly recommended and provided to customers.

- Is the facility safe? Yes, we have sanitized the facility and have developed and revised standard operating procedures to keep the facility disinfected. All procedures are in line with CDC, state of NM CSP's and Wynn gaming standards for COVID safe practices.
 - Why is Casino opening but we cancelled feast? Put simply, *Control or the Ability to Control Visitors*. The difference being that our feast day activities are a lot more difficult to control visitors, at the casino we have security personnel, surveillance cameras and in general the ability to control the number of guests who enter and the ability to monitor safe distancing practices.
- Ohkay Owingeh Health & Human Services Division has been delivering masks to all households. If you are in need of masks or any other assistance, please call.

- COVID Testing May 21, 22, 2020 – We just yesterday received back the results of the testing hosted at Ohkay Casino on the aforementioned dates. I hope and pray that all of you are doing well out there. I am happy to report that as of writing Ohkay still has no positives in our local community. I attribute this success to you all, you have taken actions and or steps to protect yourself and the results speak for themselves. I need to ask you to keep it up a little longer, as you have probably seen on news media there are certain parts of our state that are doing well, however we still have some areas that are problematic and we should therefore not let up. I'm going to go out on limb here and tell you that I predict first phase of partial opening up in Mid-May, that's just two weeks on a 7 day week. Hang in there.

Updates:

- We have taken the first steps toward the re-opening of tribal government. After consultation with our COVID-19 Response Team, the decision was made to start bringing back non-essential staff on a part time basis. The building is still closed to public but you can now receive some services on limited basis, please call and we can help direct you.
- The New Moon Lodge will re-opening under new guidelines that are intended to eliminate the risk of clients coming in with COVID-19
- Utility Payments – We will continue with the suspension or not requiring payment at this time for utility bills. The department is not turning water off that too has been suspended. Our Public Works division is working on a plan to accommodate the missed months.
- There is a Food Giveaway being conducted at the Ohkay Casino Parking lot. **It will happen again this coming Wednesday May 6, 2020.** This activity is being conducted by the Santa Fe Food Depot, a non-profit organization. The Tsay Corporation is merely letting them use the parking lot.
- Gardening – Please be cautious about not making your home gardens to large if you are going to use domestic water. I'm not saying you cannot plant gardens and use your hose to water, were just saying that if you do this, please be cautious about the size of garden you plant.

Message from Tribal Officials,

- I want to make all Tribal members aware of new temporary burial procedures. Please review the post on this web page that outlines the new/modified protocols we have put in place. The tribal Council and our Spiritual Leaders have all come to an agreement on this.
- How long will the stay at home order be in place? The quick answer is I don't know. We are right now developing a plan to start at least a slow phased re-opening, but as to when, it depends on some criteria that we are monitoring. First and foremost is the data, I am speaking here to the number of cases of COVID-19. As soon as we see these numbers hold or not grow it will be indicative of reaching the peak (you have probably heard the phrase flattening the curve - same thing). Once we reach peak it should start declining. There are other variables as well, but this is probably the main criteria for lifting the order.
- Is our Pueblo Closed? Yes, but to clarify further it is closed to those who have no reason to be here. It is not closed on the basis of if you are a Tribal member or not a Tribal member. Consider, we have numerous non-tribal members who live and work here, we have numerous programs who offer services to non-tribal members, and we have neighbors who pass through daily to get home. Can non-tribal people exercise/walk on our lands? Yes, so long as they and we practice distancing. The enemy here is not the non-tribal member rather it is the COVID-19 which is only a threat if we have close contact with others. Outdoors and distance the risk is minimal. It's why we still have Pueblo non-tribal contractors doing work here still today.

**Department of Health announces revised
testing criteria for COVID-19**

Guidelines relaxed to allow more New Mexicans to be tested.

SANTA FE –The New Mexico Department of Health (NMDOH) is providing today revised testing criteria announced by Department of Health Cabinet Secretary Kathy Kunkel during Governor Michelle Lujan Grisham’s news conference Tuesday afternoon.

Thanks to increased statewide testing capacity, the following people may now be considered for COVID-19 testing:

- Asymptomatic people who are close contacts or household members of New Mexico residents who have already tested positive for the coronavirus;
- Asymptomatic residents in nursing homes;
- Asymptomatic people in congregant settings such as homeless shelters, group homes, detention centers;
- Symptomatic people displaying the COVID-19 symptoms of cough, fever or shortness of breath.

Previous testing criteria consisted of those symptomatic or a recent out of state or country travel history.

“Studies are suggesting that asymptomatic people may be driving the spread of COVID-19, making it more difficult for containment,” said Secretary Kunkel. “If we can keep more asymptomatic COVID-19 positive patients at home and not out in public, the more effective we will be at flattening the curve.”

If there's a medical breakthrough, you're not going to hear about it for the first time from an ad or sales pitch. At this time, there also are no FDA-authorized home test kits for the Coronavirus.

Email and Text Scams

Don't click on links from sources you don't know. It could download a virus onto your computer or device. Make sure the anti-malware and anti-virus software on your computer is up to date.

Robocalls

Hang up on illegal robocallers. Don't press any numbers. The recording might say that pressing a number will let you speak to a live operator or remove you from their call list, but it might lead to more robocalls, instead.

Government Relief Checks

Expect scammers to take advantage of this. Here's what you need to know: The government will not ask you to pay anything up front to get this money. The government will not call to ask for your Social Security number, bank account, or credit card number. Anyone who does is a scammer.

Fake Charities

Do your homework when it comes to donations. Use the organizations listed at [ftc.gov/charity](https://www.ftc.gov/charity) to help you research charities. If someone wants donations in cash, by gift card, or by wiring money, don't do it.

Greetings from Tribal Administration,

In consideration of recent events I want to provide information about tribal programs during these times of crisis. Many of these information points are based on inquiries we have already received in the office. If your question is not answered please feel free to call.

1. Is the Drinking Water Safe? Yes the drinking water is safe. Our Ohkay Natural Resource Environment department, tests the water and will continue to monitor this on an on-going basis. Please rest assured the DRINKING WATER IS SAFE.
2. Ditch Work? **Ditch work for 2020 is CANCELLED.** Please help pass the word. Our rationale for the cancellation is twofold 1) There is a lot of water in ditch system and 2) COVID-19 and our efforts to not gather large groups of people.
3. Are Tribal Admin Offices Open? The Tribal government is open, however we are operating on an “Essential Personnel” only mode. Furthermore access to the Administration building will be limited. This means the doors will be locked and we are encouraging people to call ahead. Related to this we have also instituted the following;
 - a) Utility payments will cease and all shut offs are suspended indefinitely
 - b) General Assistance recipients will be asked to call ahead
 - c) Seniors, Wellness, BGC and teen Center are closed. Employees will work together to provide meals via home delivery to seniors. They will also be doing welfare checks
 - d) PD will be on duty, however courts will be closing except for emergencies. This suspends all PO, ticket payment etc.
 - e) All tribal departments will be allowing employees to work from home and or use vacation and sick leave if they so choose.

NM Department of Health regarding questions centered around testing. Below are common questions that I have been asked.

Question 1: When will an individual be given a COVID-19 test?

Answer: COVID-19 test will only be given to individuals who meet the criteria of having fever of 100.4 or above, shortness of breath, traveled outside of NM, and/or been in contact with someone who has tested positive for COVID-19. NMDOH did state that the main driver for the COVID-19 test is the fever of **100.4**, complemented with any of symptoms listed above.

NMDOH is recommending that individuals call the NMDOH hotline number of 1-855-600-3453 if they are experiencing symptoms and 1-833-551-0518 if individuals have general questions. It is important for individuals to call the symptom hotline before actually going into the hospital. OOHHS is recommending that community members call Josie Shije at 505-423-4373.

Question 2: If an individual from Rio Arriba County gets tested in Santa Fe and comes up positive, will the positive test result reflect Santa Fe County or Rio Arriba County?

Answer: The test result will reflect the residency of where that individual lives. In our example above, the test result will show up in Rio Arriba County.

What to do if you are around someone with symptoms or have symptoms yourself

The Centers for Disease Control and Prevention (CDC) recommends that anyone who has had close contact with someone confirmed to have, or is being evaluated for, COVID-19, should:

- Monitor health starting from the day of contact and continue monitoring for 14 days after.
- Watch for the following signs and symptoms: Fever, coughing, shortness of breath or difficulty breathing; chills, body aches, sore throat, and runny nose.

If you develop fever or any of the above symptoms, please call Ohkay Owingeh Public Health Nurse Josie Shije at 505-423-4373 and she can assist you with coordination with your healthcare provider.

How to prevent transmission

The best way to prevent infection is to avoid being exposed to the virus. The CDC recommends everyday preventive actions to help prevent spread of illness, including:

Avoid touching your eyes, nose and mouth with unwashed hands

- Stay 3 to 6 feet away from sick people as the virus is often spread by the spray of droplets
- Stay home when you have any flu-like symptoms (see list above)
- Cover coughs and sneezes with tissues and throw tissues in the trash
- Wash hands often with soap and water for at least 20 seconds (if soap and water are not available, use a hand sanitizer with at least 60% alcohol)
- Avoid handshaking or person to person contact if possible
- Please use hand sanitizer as frequent as possible

What the Ohkay Owingeh Tribal Government is doing

- All out of state travel have been canceled until further notice. In state travel is at the discretion of the Ohkay Owingeh Divisional Directors.
- Employees are encouraged to stay home if they are sick or experiencing flu like symptoms.
- We have vamped up sanitation efforts in the administration building as a precautionary health measure.
- It is recommending that any business within the tribal government office should be limited to essential business.
- All community events and gatherings have been postponed to further notice.
